

TRAILS VILLAGE CENTER ART FESTIVAL

November 7 & 8, 2009 Saturday & Sunday 10 until 5

Trails Village Festival, a juried fine arts and select crafts show, will be held outdoors at the Trails Village Center, located on Village Center Drive across from the Summerlin Library in northwest Las Vegas.

Open to all media of fine art and fine craft, no commercial or hobby will be allowed. The jewelry category is limited. Any artisan refused for any reason will have check returned uncaashed. Once accepted, there will be no refunds for any reason. Deadline for application is August 7 with late entries taken on a wait-list/space available basis. Booth fees received within 30 days of event must include \$20 late fee.

The show will take place along the common walkways as well as in the parking area. There are spaces for 10'x10' canopies. The versatile spaces are located under the overhang of the shops, partially shaded. Artsy displays with umbrellas are preferred for this "art walk" atmosphere.

To apply, send \$325, \$25 jury fee (separate checks), 2 photos of your work (4"x6" prints), 1 of your display and 2 self-addressed stamped envelope for acceptance notification and set-up letter. Photos will be submitted to the Trails Center for screening and will not be returned. Applications from returning artists must include requested photos AND JURY FEE. Jurying will be based on uniqueness of work as well as booth appearance.

Each participant must provide his or her own display. Weighted displays are advised.
